Aims and objectives

At The Blue Coat School Liverpool, every student belongs, is valued, and is empowered to thrive. Guided by Non Sibi Sed Omnibus — not for oneself but for all — we honour our story with honesty while forging a modern, inclusive future.

We celebrate individuality and champion diversity, inspiring students to flourish in their own way with confidence, curiosity, resilience, and kindness.

Our vision is to ignite ambition and nurture integrity and compassion, preparing young people to shape a fairer, brighter world — in Liverpool and beyond.

The purpose of the policy is to:

- Provide a clear and consistent framework for school uniform expectations that supports the school's vision and ethos and contributes to a sense of belonging and pride among students.
- Enable the Board of Trustees and school leadership to uphold standards that promote equity, inclusion and a positive learning environment through a uniform approach that is practical, respectful of diversity and reflective of the values of The Blue Coat School.
- Support the school community in maintaining high expectations for student appearance, helping to reduce peer pressure and distractions, and reinforcing a culture of discipline, self-respect, and readiness to learn.
- Ensure alignment with national guidance and statutory responsibilities, including:

Equality Act 2010: ensuring policies do not discriminate unlawfully on the basis of protected characteristics

Roles and responsibilities

The Board of Trustees will ensure this policy:

- Complies with national guidance and statutory requirements
- Is applied consistently and fairly
- Is reviewed regularly

The Headteacher will:

- Ensure the policy is communicated effectively and enforced consistently
- Support staff in implementing the policy

- Make decisions on exceptional cases and requests for adjustments

The Achievement Progress Leaders and Form Tutors will:

- Monitor student compliance with the uniform policy daily
- Support students in meeting uniform expectations
- Communicate with parents where there are concerns

Parents and Carers will:

- Ensure their child attends school in full, correct uniform every day
- Communicate any concerns or difficulties regarding uniform

Students will:

- Take personal responsibility for wearing the correct uniform
- Show pride in their appearance and school identity

Procedures and practices

General principles

Uniform must be worn correctly at all times including on the journey to and from school.

Uniform requirements apply equally to all students with adjustments available where appropriate.

Students must maintain a clean and tidy appearance.

The school reserves the right to make decisions about uniform compliance in line with this policy.

Uniform expectations

Compulsory Items (Years 7-11)

- School blazer, blue braid and blue cord
- Grey V neck jumper or cardigan with Blue Coat crest
- White shirt
- Charcoal grey regular fit trousers (not slim fit, tight fitting or bootleg)
or
Knee length pleated charcoal grey skirt
- School tie
- Plain black shoes that can be polished
- Grey socks or grey tights
- Dark hair bobbles to tie hair back where required
- No jewellery is permitted including earrings and facial piercings
- Nail polish, false eyelashes and make up are not permitted

PE Kit

- BCS house PE shirt
- BCS quarter zip training shirt
- BCS royal blue shorts or skort
- Navy blue tracksuit bottoms (BCS or plain, no branding allowed) and/or BCS leggings
- BCS royal blue PE socks
- Trainers (no black soles)
- Football boots
- Shin pads
- Black or navy blue swimming shorts or swimming costume
- Towel
- Swimming hat and goggles

Compulsory Items (Years 12-13)

- School blazer, yellow braid and yellow cord
- Grey or navy V neck jumper or cardigan with Blue Coat crest
- White shirt
- Charcoal grey regular fit trousers (not slim fit, tight fitting or bootleg)
or
Knee length pleated navy skirt
- School tie
- Plain black shoes that can be polished with heel no greater than 3 cm
- Dark hair bobbles to tie hair back where required
- A single stud earring in each ear is permitted
- Any other jewellery including facial piercings are not permitted
- Natural nail polish is permitted
- Make up including false eyelashes is not permitted

Non-compliance

Persistent non-compliance will be dealt with under the school's behaviour policy.

Parents/carers will be contacted when students fail to meet expectations.

Reasonable Adjustments

The school will consider reasonable requests for adjustments to uniform based on:-

Religious beliefs
Cultural traditions
Medical needs
Special educational needs or disabilities

Purchasing and Affordability

The school is committed to keeping uniform costs reasonable and avoids unnecessary branded items.

Annex A: School Uniform Years 7-11

School expects students to wear the school uniform smartly when at school and when travelling to and from school.

All items of uniform should be clearly marked with your full name.

All students

School Uniform

- ✓ School blazer, blue braid and blue cord
- ✓ Grey V neck jumper or cardigan with Blue Coat crest
 - ✓ White shirt
- ✓ Charcoal grey regular fit trousers (not slim-fit, tight-fitting or bootleg)
OR
 - ✓ Knee length pleated charcoal grey skirt
 - ✓ Plain black shoes that can be polished
 - ✓ Grey socks or grey tights
 - ✓ School tie
 - ✓ Lanyard and student card (supplied by school)
 - ✓ Dark hair bobbles to tie hair back where required
- ✓ No jewellery is permitted, including earrings and facial piercings
- ✓ Nail polish, false eyelashes and make-up are not permitted

PE Kit

- ✓ BCS house PE shirt
 - ✓ BCS quarter zip training top
 - ✓ BCS royal blue shorts or skort
 - ✓ Navy blue tracksuit bottoms (BCS or **PLAIN** – no obvious branding) and/or BCS leggings
- Other Equipment:**
- ✓ BCS royal blue PE socks
 - ✓ Trainers (no black soles)
 - ✓ Football boots
 - ✓ Shin pads
 - ✓ Navy blue/black swimming shorts or costume, swimming hat, goggles and towel (Year 7 only)

All items of uniform should be clearly marked with your full name.

- ✓ School blazer, yellow braid and yellow cord
 - ✓ Grey or navy V neck jumper or cardigan with Blue Coat crest
 - ✓ White shirt
 - ✓ School tie
 - ✓ Grey regular fit trousers (not slim fit, tight fitting or bootleg)
- OR
- ✓ Knee length pleated navy skirt
 - ✓ Either grey or navy socks or navy tights
 - ✓ Plain black shoes that can be polished with heel no greater than 3 cm
 - ✓ Dark hair bobbles to tie hair back
 - ✓ A single stud earring in each ear is permitted
 - ✓ Facial piercings are not permitted
