# Financial Statements for the year ended 31st August 2017

During our audit we have reviewed the accounting systems and procedures operated by the Academy. We have also conducted an examination, on a test basis, of evidence relevant to the amounts and disclosures included in the financial statements and considered whether the accounting policies are appropriate to the Academy's circumstances, consistently applied and adequately disclosed.

Our review of the accounting systems and procedures did not reveal any exceptions and our examination of evidence relevant to the financial statements revealed no matters that we wish to bring to your attention. Full details of these matters are stated in Appendix 1 which follows this letter.

We would point out that the matters dealt with in this report came to our notice during the conduct of our normal audit procedures which are designed primarily for the purpose of expressing our opinion on the financial statements of the Academy. In consequence, our work did not encompass a detailed review of all aspects of the system and cannot be relied upon, necessarily, to disclose defalcations or other irregularities or to include all possible improvements in internal control that a more extensive special examination might develop.

Aside from the external audit of the financial statements for year ended 31st August 2017, we have also provided quarterly reports supporting the Academy's Internal Audit Function during the year. During this process, our review of the accounting systems and procedures revealed some exceptions and our examination of evidence relevant to the financial statements revealed matters that we were brought the Governors' attention each quarter and subsequently corrected. We have summarised these matters in Appendix 2
